Can We Find You?

Every second counts when Firefighters, Police, and medical personnel are responding to an emergency 911 call. The Aurora Fire District is concerned about locating people during their time of need. Please take a moment to check your address sign for proper identification of your residence. This could be the difference in saving or losing lives and property.

The address sign should be clearly visible from the street. Numbers should be 3-4" in height. When placing numbers on your mailbox, please be sure that there are numbers on both sides. When placing numbers on your house, please be sure that they are a contrasting color from your house, and easily seen from the street.
